BPW96 is a high speed and high sensitive silicon NPN epitaxial planar phototransistor in a standard T–1³/₄ (ø 5 mm) package. Due to its waterclear epoxy the device is sensitive to visible and near infrared radiation. The viewing angle of $\pm 20^{\circ}$ makes it insensible to ambient straylight.







Figure 1. Total Power Dissipation vs. Ambient Temperature










 $E_e - Irradiance (mW/cm^2)$






Figure 6. Collector Emitter Capacitance vs. Collector Emitter Voltage





Figure 7. Turn On/Turn Off Time vs. Collector Current






